

Prohibited Countries/Regions and Office of Foreign Assets Control (OFAC) List

3.2.5 Prohibited Countries/Regions

A Member may not be a resident of a "Prohibited Country/Region". *

Additionally, a Member may not directly or indirectly conduct any Herbalife Nutrition business activities with an individual or entity who the Member has reason to believe is:

- (i) a resident of, or operating businesses in, a Prohibited Country/Region;
- (ii) engaged in sales to individuals residing in a Prohibited Country/Region; or
- (iii) owned or controlled by an entity located in, or an individual ordinarily residing in, a Prohibited Country/Region.

Business activities include but are not limited to the following:

- Promoting the Herbalife Nutrition opportunity;
- Sponsoring or recruiting Members or Customers; or
- Promoting or selling Herbalife Nutrition products.

Violation of this Rule will result in termination of one's Membership.
