KÄYTTÖOHJE: Hiero kuorintavoidetta kostutetulle iholle hellävaraisesti pyörivin liikkein (vältä silmänympärysihoa). Huuhtelee lämpimällä vedellä ja taputtele iho kuivaksi. Viimeistele lopuksi kasvovedellä, seerumilla ja kosteusvoiteella. Käytä 1-3 kertaa viikossa tarpeen mukaan.

ANVÄNDNING: Massera varsamt in i scrubben på fuktig hud med cirklande rörelser (undvik ögonkonturen). Rengör med ljummet vatten och badna huden torr. Avsluta med ansiktsvatten, serum och fuktkräm. Använd 1 till 3 gånger i veckan efter behov.

BRUK: Masseres varsomt inn i fuktig hud med sirkelbevegelser (unngå området rundt øynene). Skyll med varmt vann, klapp huden torr. Fortsett med ansiktsvann, serum og fuktighetskrem. Brukes 1-3 ganger per uke, ved behov. Huom.: Säilytettävä lasten ulottumattomissa. Vain ulkoiseen käyttöön. Vältä tuotteen joutumista silmiin.
