All Fully Qualified Supervisors will receive Bonus Points for their Total ELITE CLUB Points to be used toward the following qualifications: ELITE CLUB and ELITE CLUB PLUS

Volume Points achieved as a Qualifying Supervisor at a temporary 50% discount may be utilized toward ELITE CLUB status.

ELITE CLUB Status

Qualification Period: January–March 2026

Open to all Fully Qualified Supervisors who achieve the following:

A minimum of 2,500 Total Volume Points (TVP) each month for three consecutive months during the qualification period.

-And-*

ELITE CLUB

*Accumulate 25,000 ELITE CLUB Points over three months.†

ELITE CLUB PLUS

*Accumulate 35,000 ELITE CLUB Points over three months.†

Additional ELITE CLUB PLUS Pathway:

*Accumulate 30,000 ELITE CLUB Points over three months; this must include one month of 10,000 Royalty Override in one of the three months (January, February or March).†

† ELITE CLUB Points include TVP and Bonus Points.

Bonus Points†

Earn Bonus Points toward ELITE CLUB perks by recruiting new Distributors, encouraging them to qualify for promotions and helping them grow their businesses!

500 Bonus Points for New Preferred Customers

All new Worldwide Preferred Customers in your first line who place an order of 100 Total Volume Points during the first 30 days (with an application month in January–March 2026).

1,000 Bonus Points for New Distributors

All new Worldwide Distributors in your first line who achieve a minimum of 100 Total Volume Points during the first 30 days (with an application month in January–March 2026).

2,000 Bonus Points for New Supervisors

All new Supervisors in your first line within recognition months (February 1, March 1, and April 1, 2026).

7,500 Bonus Points for ASP Qualifiers

All North America first-line, first-time Active Supervisor Promotion qualifiers within recognition months (February 1, March 1, and April 1, 2026).

Recognition Months Example for New Supervisors and ASP Qualifiers

Volume Months	Recognition Months
Nov. 2025, Dec. 2025 and Jan. 2026	February 1
Dec. 2025, Jan. 2026 and Feb. 2026	March 1
Jan. 2026, Feb. 2026 and March 2026	April 1

‡Bonus Point Rules

Bonus Points will be used toward the accumulated Total Volume Points for ELITE CLUB and will not count toward earnings or any other qualification or promotion.

- If a new Preferred Customer signs up in March 2026, their Total Volume needs to be completed by March 31, 2026
- If a new Distributor signs up in March 2026, their Total Volume needs to be completed by March 31, 2026
- Only Active Supervisor Promotion qualifiers in North America will count toward the Bonus Points
- Any Distributor or Preferred Customer that has previously been deleted/left who becomes a Distributor or Preferred Customer again, between January to March 2026, and meets the 100 TVP requirement will count as a bonus
- All conversions must be personally sponsored with an application or conversion date during January to March 2026
- New Distributors or Preferred Customers who reactivate after being dormant between January and March 2026, and meet the 100 TVP requirement, will count as a bonus
- If a Distributor converts to Preferred Customer, they will only be counted as long as the conversion to Preferred Customer was for the first time ever in their Herbalife journey during the qualification period
- If a Preferred Customer converts to Distributor, they will only be counted as long as the conversion to Distributor was for the first time ever in their Herbalife journey during the qualification period
- If your downline Preferred Customer converts to a new Distributor in the same month, the volume they achieved as a Preferred Customer will not count. Only Volume Points achieved as a Distributor will count toward the 100 TVP requirement. Volume achieved as a Preferred Customer will not count.
