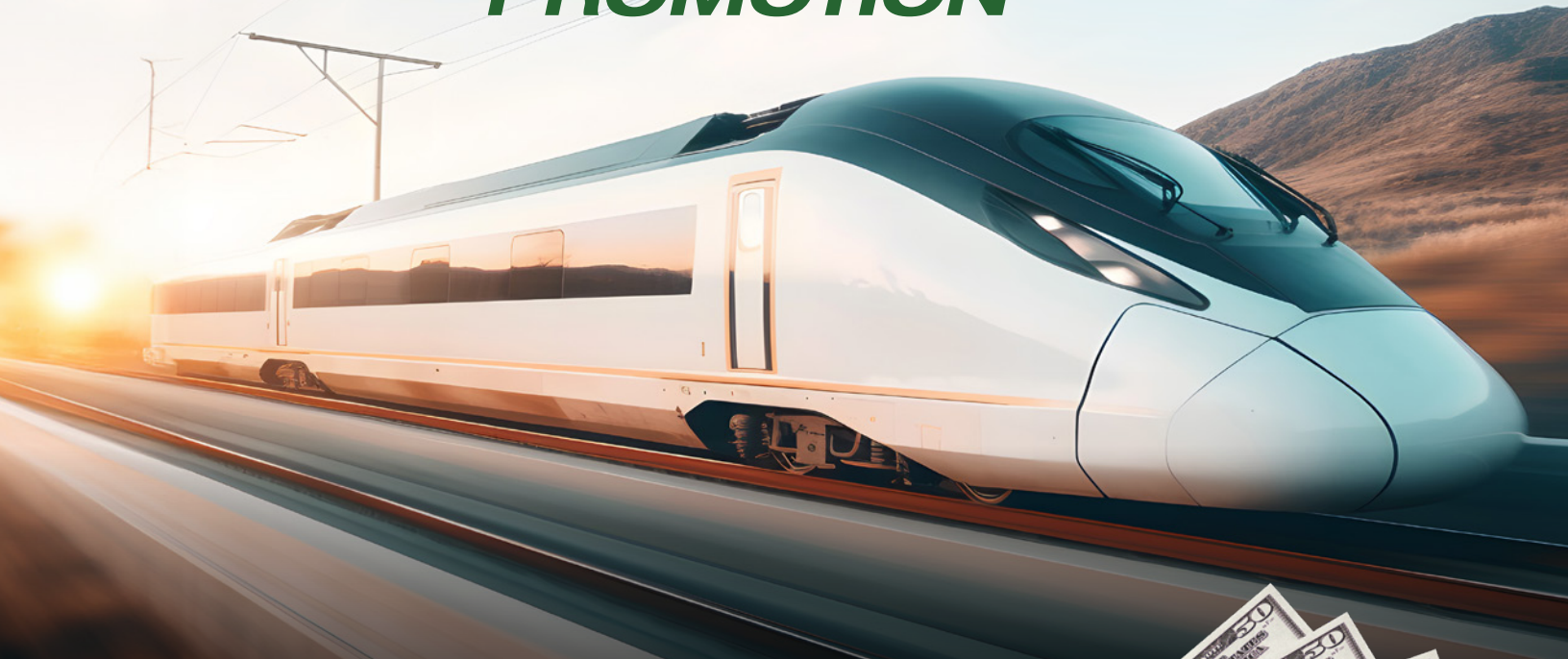


# **SPEED TO SUPERVISOR PROMOTION**

## Who Can Qualify

Open to Herbalife Independent Distributors who are not Fully Qualified Supervisors with an application date between **January 1, 2023, and December 31, 2024**

## When to Qualify

Qualification period: **October through December 2024**

## How to Qualify

Accumulate **4,000 Volume Points (with at least 1,000 Unencumbered Volume Points) over 1 to 3 consecutive months<sup>†</sup>**

<sup>†</sup>New Herbalife Independent Distributors with an application month of November 2024 will have until January 31, 2025, to complete the qualification. New Herbalife Independent Distributors with an application month of December 2024 will have until February 28, 2025, to complete the qualification.

## Achieve Supervisor Status in Three Ways

1 month	4,000 VP	US\$200 cash reward

**3 Supervisors**

In this example, everybody becomes a Supervisor: 50% Certificate and Pin. Distributors who are qualifying for Supervisor in line with their downline Distributors may contact Member Services for assistance, if needed. This is one of several methods that can be used to qualify to Supervisor.

All rewards are stated in U.S. dollars. Reward payouts will be made in local currency.

A special cash payment for qualifiers will be made on the following month after completing the qualification.

# Promotion Rules

1. Qualifiers must be in good standing with the Company. Qualification will be confirmed at the sole discretion of Herbalife. The Speed to Supervisor Promotion is open to all Non-Fully Qualified Supervisors in North America with an application date between January 1, 2023, and December 31, 2024.<sup>‡</sup>
2. Worldwide Documented Volume will be used for qualification for this promotion.
3. For U.S./Puerto Rico Distributors, all volume required to qualify for this promotion must be Documented Volume. For details, refer to the U.S. Sales & Marketing Plan.
4. Reward payouts will be made in local currency via a special payment date in the same manner that Royalty Earnings and Production Bonuses are paid out, per any existing agreement.
5. Distributors are solely responsible for any and all taxes associated with the promotion.
6. Qualifications are based on the achievements of the individual Distributorship. Divorced Distributors with split IDs may combine 100% of the volume from the original (joint) ID, plus 100% of the volume on their “new” (individual) ID.
7. If a monetary reward is earned by both associated IDs, the reward amount will be divided in half between each Distributor ID. Herbalife will review all cases at the end of the qualification period and determine the reward payout.
8. Should any of the volume required to qualify for this promotion result in a repurchase of products by Herbalife, Herbalife will deduct the cost of the rewards from the qualifier’s earnings.
9. Distributors must claim their reward and raise all questions and disputes regarding this promotion within 90 days of the end of the promotion period.
10. Herbalife reserves the right to change, modify, extend or withdraw this promotion at any time in its sole discretion and without prior notice.
11. For all methods of Supervisor qualification, once achieved, Distributors are automatically updated to Supervisor status on the first of the month following completion of their qualification. Distributors who are qualifying for Supervisor in line with their downline Distributors may contact Member Services for assistance, if needed. Supervisors who do not re-qualify their Supervisor status will be updated to the Qualified Producer level.
12. New Distributors with an application month of November 2024 will have until January 31, 2025, to complete the qualification.
13. New Distributors with an application month of December 2024 will have until February 28, 2025, to complete the qualification.
